# 3.2 Chemical characterization: Mixtures

#### **Description of product:**

Strep-Tactin® and Strep-Tactin XT® are muteins of streptavidin, an extracellular protein of *Streptomyces avidinii* that binds biotin with high affinity. Strep-Tactin resins themselves do not contain any hazardous components. Small quantities of tris, sodium azide, and EDTA have been added to the suspension to increase shelf life.
